JPA AMMENDMENT

5.0 New Business

ENGINE REPAIR – UNIT 462

The Board discussed the issue of a blown engine on Unit 462. The discussion included the age of the unit, cost of repair vs cost of replacement unit. The Chief presented the Board with three bids for the repair work. After much discussion the Board decided to accept the bid to River City Deisel Repair in the amount of \$ 31,812.49. Board Chairman Johnson made a motion award the contract to River City Deisel repair, Board Member Coe seconded.

The Chief is to meet with the Insurance Services Office (ISO) at the end of the month as it is time for the 5 year rating process to take place. The current rating is 3.
